




Average 1-Quarter Return on Avg. Assets (%)




Quarterly net income / average assets, annualized

Net Interest Margin (%)




Quarterly net interest income / average earning assets, annualized

Avg. Nonperforming Assets / Total Assets (%)




Nonperforming: 90 + days past due + nonaccrual + other real estate owned

Avg. Net Loan Growth Rate, Year-Over-Year (%)




Avg. Short-Term Investments / Total Assets (%)
