







Population with High School Diploma/GED or Above, 2013












Population that is Hispanic or Latino, 2013







Population Over Age 16 by Occupation, 2013 Western Washington

















Housing Stock by Type, 2013 Western Washington



Housing Stock by Year Constructed, 2013 Western Washington






