62% of children under 6 have all available parents in the labor force, up from 57% ten years ago.¹

COVID-19 Poses a New Threat to the Child Care Sector

Capacity is declining in ID³

53% child care slots could be lost **53%** of child care slots could be lost. Pre-pandemic in ID there were 2.7 children for every available slot. With COVID closures that number could go as high as 5.8.


Provider costs are increasing in ID $^{\scriptscriptstyle 4}$

Center-based providers' costs are estimated to increase by **10%**.

Family-based providers' costs are estimated to increase by **73%**.

The Child Care Sector Was Struggling Prior to COVID-19

Child care workers struggled to make ends meet 21% of child care workers in ID lived in poverty.⁵





Child care is hard to find for many families49% of people in ID were living in a child care desert.⁹

Costs of providing care were high in ID⁶ \$840/month for center-based infant care

\$840/month for center-based infant care \$720/month for center-based toddler care \$620/month for family-based care

Subsidies were insufficient⁷

A minimum wage worker in ID spends **50%** of their earnings on child care, on average.¹⁰
