Nancy O. Andrews

President and CEO
Low Income Investment Fund

Ms. Andrews is the President and Chief Executive Officer of the Low Income Investment Fund (LIIF), a \$800 million Community Development Financial Institution. Ms. Andrews serves on numerous community development and environmental boards and committees, including Bank of America's National Community Advisory Council, Morgan Stanley's Community Development Advisory Committee, Capital One's Community Advisory Council, and the National Housing Law Project. She was also previously a member of the Federal Reserve Board's Consumer Advisory Council.

Ms. Andrews' 30 years in community development include positions as Deputy Director of the Ford Foundation's Office of Program Related Investments and Chief Financial Officer of the International Water Management Institute, a World Bank-supported development organization. Ms. Andrews also consulted for the Department of Housing and Urban Development and the Department of Treasury during the Clinton administration. She received an M.S. in Urban Planning with a concentration in Real Estate Finance from Columbia University.

Leilani Barnett

Regional Manager, Community Development Federal Reserve Bank of San Francisco

Leilani Barnett leads multi-sector collaborations to overcome community development problems by building on local assets in the inland areas of California from Kern County north. Through public/private/community-based partnerships, Ms. Barnett helps low- and moderate-income communities and families with workforce development, affordable housing, health, education, economic development, financial services, and small business and rural development.

Ms. Barnett's past experience includes having managed the Sacramento Housing and Redevelopment Agency's Section 8 (HCV) program, benefiting 12,000 low-income families. She has also worked as a consultant to Cities and Counties throughout California, and she has an extensive background in private real estate development, including transit-oriented, infill, mixed-use development, affordable housing, and master-planned communities. She has served on a City Planning Commission, local housing advisory commission, technical advisory boards, and on the Sacramento County Children's Coalition. Ms. Barnett has held a California real estate broker's license. She received a B.A. from Brown University and a Master's degree in City and Regional Planning from U.C. Berkeley. She is based in Davis.

Claudia Cappio

Director

California Department of Housing and Community Development

On August 8, 2014, Governor Edmund G. Brown, Jr. appointed Ms. Cappio as Director of the State Department of Housing and Community Development. Prior to this appointment, Ms. Cappio also held the appointed position of Executive Director of the California Housing Finance Agency since 2011.

Ms. Cappio previously acted as Principal at Sparticles LLC, a planning and development consulting firm and served the City of Oakland as Director of Planning, Building, Major Projects and the Oakland Base Reuse Authority during then-mayor Edmund G. Brown, Jr.'s Administration. While in this capacity, she was responsible for spearheading major public and private development, including the Oak to Ninth Project (with 3,000 housing units), the Wood Street Mixed Use Project (1,500 residential units), and the 10K Program, which approved construction of 6,000 residential units in downtown Oakland for 10,000 residents.

Her experience in municipal planning and building also included many years of service to the cities of Emeryville, Albany and Corte Madera in California. Ms. Cappio received a Bachelor of Arts degree in Urban Studies from Ohio Wesleyan University.

Tina N. Castro, CFA

Founder and Principal
Avivar Capital

Tina Castro is the founder and Principal of Avivar Capital, an impact fund syndicator, asset manager and advisory services firm focused on developing coordinated Community Development Families of Funds, managing those assets on behalf of clients and providing impact investment advisory services. Ms. Castro brings over 11 years of experience in the fields of finance and investment management including most recently more than five years as the Director of Impact Investing for The California Endowment (TCE) and prior to that, six years in the Investment Management Division at Goldman, Sachs & Co. At TCE, a health-focused private foundation with over \$3 billion in assets, Ms. Castro developed financing vehicles and strategies that delivered solid financial returns, leveraged significant additional investment capital and supported TCE's Building Healthy Communities goals. This included the California FreshWorks Fund, a \$272 million public-private partnership loan fund to finance supermarkets and other forms of healthy food retail in underserved communities throughout the state as well as TCE's \$101 million Program-Related Investment portfolio focused on healthy food retail, community health centers, affordable housing and community lending. She also oversaw TCE's \$90 million seed investments into two start-up impact funds which included a start-up mezzanine debt fund and a start-up venture capital fund.

Ms. Castro is experienced in developing, implementing, tracking and reporting on social impact metrics as well as tracking and analyzing the costs associated with managing an impact portfolio. She designed and implemented TCE's impact investing portfolio social and financial tracking systems which included a series of customized dashboards and made use of conventional systems such as Mellon Workbench and Private I. She is a CFA charterholder, has two Master's Degrees — an MBA from the UCLA Anderson School of Management with a focus in Finance and an MA from the University of Miami in International Affairs with a focus in International Business as well as a BA Cum Laude in International Relations with a focus in Latin America from the University of Colorado at Boulder.

David Derauf

Executive Director Kokua Kalihi Valley Comprehensive Family Services

David D. Derauf, MD, MPH has been with Kokua Kalihi Valley Comprehensive Family Services (KKV), a federally qualified community health center in Honolulu for the last 25 years. In 1989, he was hired as KKV's first Clinical Director and remained in this position until being named as KKV's Executive Director in October, 2003. Dr. Derauf has served as Assistant Clinical Professor of Public Health, Medicine, and Nursing at the University of Hawaii. He serves as a board member of the Association of Asian and Pacific Island Community Health Organizations



(AAPCHO), the Hawaii Primary Care Association, and Aloha Care, a Hawaii Medicaid Managed Care Corporation, as well as Lawyers for Equal Justice. He is also a member of Na Limahana o Lonopuha, a consortium of Native Hawaiian Health Organizations.

Under his leadership, KKV was named a Center of Excellence in Women's health care by the Federal Government in 2002. In 2008 KKV was honored by HRSA with its Special Populations Service Award, recognizing KKV's excellence in service to minority populations. In 2009, Dr. Derauf was chosen by the Director of Health to represent Hawaii on the inaugural California-Hawaii Public Health Leadership Institute Team. He was given a Gerbode-Hawaii Community Foundation Award for non-profit leadership in 2008 and three times received a Harry and Jeannette Weinberg Foundation Award for Excellence in Management.

Dr. David Frickson

Director, Center for Community Development Investments Federal Reserve Bank of San Francisco

Dr. David J. Erickson is director of the Center for Community Development Investments at the Federal Reserve Bank of San Francisco and edits the Federal Reserve journal *Community Development Investment Review*. His research areas in the Community Development department of the Federal Reserve include community development finance, affordable housing, economic development, and institutional changes that benefit low-income communities.

Dr. Erickson has a Ph.D. in history from the University of California, Berkeley, with a focus on economic history and public policy. He also holds a master's degree in public policy from Berkeley and an undergraduate degree from Dartmouth College. He is a leader in the collaboration between the Federal Reserve and the Robert Wood Johnson Foundation on bringing health together with community development. To date, this collaboration has resulted in 11 conferences around the country and numerous publications, including a cluster of articles in *Health Affairs* in November, 2011. His book on the history of community development, *The Housing Policy Revolution: Networks and Neighborhoods*, was published in 2009 by the Urban Institute Press. He also co-edited *Investing in What Works for America's Communities: Essays on People, Place, and Purpose* (2012).

Dr. Sandra R. Hernández

President and CEO
California HealthCare Foundation

Dr. Sandra R. Hernández became president and CEO of the California HealthCare Foundation in January 2014. CHCF is an independent foundation with assets of more than \$700 million, headquartered in Oakland, California, and dedicated to improving the health of the people of California.

Prior to joining CHCF, Dr. Hernández was CEO of The San Francisco Foundation, which she led for 16 years. She previously served as director of public health for the City and County of San Francisco.

Dr. Hernández is an assistant clinical professor at the University of California, San Francisco, School of Medicine and maintains a clinical practice at San Francisco General Hospital in the AIDS clinic. She is a graduate of Yale University, the Tufts School of Medicine, and the certificate program for senior executives in state and local government at Harvard University's John F. Kennedy School of Government.

Originally from Tucson, Arizona, she spent much of her childhood in rural New Mexico with her grandparents. There she came to honor and appreciate her Mexican culture and the intrinsic values of community and public service. Her love of science and math was nourished by her father, a self-educated engineer.

Dr. Hernández serves as a trustee of the Reno-based Asbestos Settlement Trusts and as an independent director of First Republic Bank, Blue Shield of California, and the Blue Shield of California Foundation. She is a member of the Public Policy Institute of California's Statewide Leadership Council, the Yale University President's Council, the UCSF Chancellor's Advisory Board, and the UCSF Clinical and Translational Science Institute Advisory Board.

Her earlier affiliations include President Clinton's Commission on Consumer Protection and Quality in the Healthcare Industry, and two Institute of Medicine committees — on the Consequences of Uninsurance and on the Implementation of Antiviral Medication Strategies for an Influenza Pandemic.

She is a former board member of Grantmakers In Health, the Council on Foundations, and the California Managed Risk Medical Insurance Board (MRMIB). She co-chaired San Francisco's Universal Healthcare Council, which designed Healthy San Francisco, an innovative health access program for the uninsured.

Chet Hewitt

President and Chief Executive Officer
Sierra Health Foundation

Chet P. Hewitt is the President and Chief Executive Officer of Sierra Health Foundation and its independent operating unit, the Center for Health Program Management. Since beginning his tenure in 2007, Mr. Hewitt has focused foundation investments on health disparities, health equity, and the healthy development and well-being of vulnerable youth. His leadership, thoughtful risk taking and innovative approach to management have increased the foundation's impact, reach and influence.

Prior to joining the foundation, Mr. Hewitt spent five years as the Agency Director of Alameda County's Social Services Agency, where he is credited with transforming its failing child welfare system into a national model and using technology to improve the delivery of human services.

Previously, he served as Associate Director for the Rockefeller Foundation in New York, established and managed its West Coast regional office in San Francisco and led its national employment and community building initiatives. Mr. Hewitt has received several national awards, including the Annie E. Casey Foundation Child and Family Leaders Fellowship and Child Welfare Administrator of the Year.

Mr. Hewitt is a frequent lecturer on philanthropy and public sector leadership, and advises localities around the country on issues related to the transformation of public systems. He serves on several boards, including Grantmakers in Health, Sacramento Steps Forward, Roberts Enterprise Development Fund and St. John's Shelter for Women and Children.

Dr. Anthony Iton

Senior Vice President for Healthy Communities The California Endowment

Anthony Iton, M.D., J.D., MPH is Senior Vice President for Healthy Communities at The California Endowment. In the fall of 2009, Dr. Iton began to oversee the organization's 10-Year, multimillion-dollar statewide commitment to advance policies and forge partnerships to build healthy communities and a healthy California.

Dr. Iton served for seven years as the Alameda County Public Health Department Director and Health Officer where he oversaw a budget of \$112 million with a focus on preventing communicable disease outbreaks, reducing the burden of chronic disease and obesity. He has worked as an HIV disability rights attorney at the Berkeley Community Law Center, a health care policy analyst with Consumers Union West Coast Regional Office, and as a physician and advocate for the homeless at the San Francisco Public Health Department.

Dr. Iton's primary focus includes health of disadvantaged populations and the contributions of race, class, wealth, education, geography, and employment to health status. His awards include the Champion of Children Award from the United Way and the National Association of City and County Health Officials Award of Excellence for the use of information technology in public health. In February 2010, Dr. Iton was recognized by the California Legislative Black Caucus with the Black History Month Legends Award and presented on the floor of the California State Assembly with a resolution memorializing his life's work and achievements.

Dr. Iton serves on the board of directors of the Public Health Institute, the Public Health Trust, the Prevention Institute, and Jobs For The Future.

Dr. Iton received his medical degree at Johns Hopkins Medical School and subsequently trained in internal medicine and preventive medicine at New York Hospital, Yale, and Berkeley and is board certified in both specialties. Dr. Iton also holds a law degree and a Master's of Public Health from the University of California, Berkeley and is a member of the California Bar.

The Honorable Kevin Johnson

Mayor City of Sacramento

Kevin Johnson was elected as the mayor of the City of Sacramento in November 2008 and reelected to a second term in June 2012. He is the first native Sacramentan and the first African American to be elected to the office. His vision is for Sacramento to become "a city that works for everyone."

Since taking office, Mayor Johnson has embarked on an ambitious plan to reshape how city government serves the citizens of Sacramento. His top priorities include improving public safety, creating jobs and economic development, reforming public education, promoting good government, and enhancing the quality of life for all Sacramentans.

Beyond his policy goals for Sacramento, Mayor Johnson is committed to elevating Sacramento's profile as the capital city of California - the 8th largest economy in the world. To that end, the Mayor has taken on a range of national leadership positions, including his current roles as Second Vice President of the US Conference of Mayors, Vice President of the National Conference of Black Mayors, and Chair of US Secretary of Education Arne Duncan's Education Reform Task Force.

Takarra Lee Johnson

Poet and Public Speaker Sacramento Area Youth Speaks

Takarra Lee Johnson was born on January 27, 1997, to Mrs. Earlene Johnson and Mr. Carl Johnson in the city of Sacramento, CA. At 17 years of age, she is a dynamic and inspiring Poet and Public Speaker. Takarra was always a spiritual child. At the age of three, everyone in her house was subject to her prayer. Not too long after that, she told the family that she wanted to be a lawyer and acted accordingly. Takarra would draw up contracts and lists of rules and post them all throughout the house. She always meant business. She began her work in the church as a member of the Youth Choir. And on August 8, 2004, a few months after her father was murdered, Takarra publically confessed salvation and dedicated her life to the Lord wholeheartedly. She was 7 years old.

Some of Takarra's personal achievements include: Honor Roll at Sacramento Charter High School with a GPA of 3.7, and she is a member and choreographer of the MISSES Step Team. She has been involved with the Sacramento Area Youth Speaks (SAYS) program since 2012 and has performed and competed on an international stage representing the youth voice of Sacramento. Not only is Takarra an amazing Poet, she is a real and genuine voice of and for the youth in this region. She aspires to be an attorney at law after graduating from a prestigious historically Black College or University. Just this year, she has ventured into the Gospel Music Industry and expects to go far with her musical gifts. Takarra enjoys fellowshipping, witnessing and preaching the Good News of Jesus Christ daily to anyone who is willing to listen, and to those who aren't. God uses her as living encouragement to His people – both young and old. She hopes to continue to be a voice and representative for young people throughout this region.

Dr. Olivia Kasirye

Public Health Officer
Sacramento County

Dr. Olivia Kasirye received her medical degree in Uganda in 1988 and moved to the US. She completed a master's degree in epidemiology at UC Davis in 2003 and a residency in Public Health and Preventive Medicine, through the California Department of Public Health in 2004. Dr. Kasirye started working in Sacramento County, Public Health, and held several positions as Disease Controller and Maternal and Child Health Medical Director. In 2009, she was appointed Public Health Officer for El Dorado County and worked on several initiatives. In 2012, she returned to Sacramento County as the Public Health Officer. As Health Officer, she provides medical expertise and public health oversight on a variety of community-wide public health issues impacting County residents. She works with local healthcare providers and community stakeholders on public health program and policy issues. Dr Kasirye believes that community engagement is crucial to successful public health programs and is involved in several

community initiatives addressing chronic disease, STD control and health disparities. Dr. Kasirye is board certified in Public Health and Preventive Medicine.

Mike McKeever

Executive Director
Sacramento Area Council of Governments Board of Directors

Mike McKeever, AICP, was appointed Executive Director of the Sacramento Area Council of Governments Board of Directors on December 17, 2004. Previously, Mr. McKeever, was project manager of the Blueprint Project at SACOG. Mike McKeever has focused his 30 plus year career on effective regional planning. He was the owner of an urban planning consulting practice in Portland, Oregon and since 2001 was Blueprint Project Manager and then Executive Director of the Sacramento Area Council of Governments.

During Mr. McKeever's tenure at SACOG, the organization has established itself as a national leader in sustainable, integrated regional planning. He was a key contributor to California Senate Bill 375, the nation's most comprehensive regional planning law linking climate change, transportation, land use and housing planning and was appointed by the California Air Resources Board to chair the Regional Targets Advisory Committee, a 21 person statewide committee to assist in the implementation of SB375.

Prior to joining SACOG, Mr. McKeever led planning projects throughout the country, is the author of several manuals on regional collaboration, and has been the primary developer of the innovative I-PLACE3S planning software. He is often invited to speak to national and international audiences and in 2008, was featured in a front page Wall Street Journal article on the Sacramento area's unique regional planning accomplishments. He is a native of Nampa, Idaho and received his B.A. with Honors from the University of Oregon.

Jahmal Miller

Deputy Director, Office of Health Equity California Department of Public Health

William Jahmal Miller was appointed by Governor Jerry Brown as Deputy Director to the Office of Health Equity at the California Department of Public Health, starting October 2013. In August 2014, the California State Senate unanimiously voted to confirm Mr. Miller.

Previously, he served as Communications Manager with Kaiser Permanente's National Offices - Community Benefit, Health Policy & Research Division. At Kaiser Permanente, he also served in the Central Valley Service Area, where he was Manager for Community & Government Relations within the Public Affairs Division. Mr. Miller has provided overall management of for Sutter Health's Sacramento Sierra Region as Manager for Strategic Marketing &

Communications and oversight of growth, marketing and communications efforts with large-employer groups and brokers. Prior to that, he was the Program Manager for Sutter Children's Hospital at Sutter Medical Center, Sacramento. Mr. Miller was responsible for managing inpatient and outpatient operations by providing strategic direction for Sutter Children's Cancer Program and Outpatient Clinics.

He has been a board member of the California Child Care Referral and Resource Network, one of the most respected systems of child care resources and referrals in the United States. The following are additional volunteer boards where he has served - American Heart Association's Western Region Health Equity Task Force, American Diabetes Association, Bloodsource Community Advisory & Ronald McDonald House Charities. Mr. Miller completed an Executive Fellowship with the Nehemiah Emerging Leaders Program in conjunction with the American Leadership Forum & CORO.

Mr. Miller is a proud graduate of Columbia University in New York City, receiving a Bachelor of Arts Degree in Psychology, and he holds a Master of Healthcare Administration from the University of Southern California.

Sergio Palleroni

Senior Fellow, Center for Sustainable Solutions Portland State University

Sergio Palleroni is a Senior Fellow of the new Center for Sustainable Solutions at Portland State University, and a founding member and faculty of the federally funded Green Building Research Lab. Professor Palleroni's research and fieldwork for the last two decades has been in the methods of integrating sustainable practices to improve the lives of communities worldwide typically underserved.

In 1988, to serve the needs of these communities he founded an academic outreach program that would later become the BASIC Initiative (www.basicinitiative.org), a service-learning fieldwork program. Each year, the BASIC Initiative challenges students from the United States and abroad to apply their education in service of underserved communities around the globe. Today, the BASIC Initiative continues to serve the poor in Asia, Latin America, Africa and the U.S.

In addition, Professor Palleroni has worked and been a consultant on sustainable architecture and development in the developing world since the 1980s, both for not-for-profit agencies and governmental and international agencies such as UNESCO, World Bank, and the governments of China, Colombia, Costa Rica, India, Kenya, Mexico, Nicaragua and Taiwan.

The work of the BASIC Initiative has most recently been documented in *Studio At Large:*Architecture in Service of Global Communities (2004), Building a Strawbale House (2005) and

Director of Community Benefit, Greater Sacramento Service Area Dignity Health


