Rates of Interests on Advances and Discounts

The rates on advances and discounts made by the Federal Reserve Bank of San Francisco pursuant to the provisions of the Federal Reserve Act and Regulation A are effective December 15, 2016 as set forth below:

	Primary Credit	1.25%
	Secondary Credit	1.75%
(b)	Seasonal credit advances pursuant to section 201.4(c) of Regulation A	Flexible Rate ²

This schedule of rates supersedes the previous schedule that was effective December 17, 2015.

¹ The Board of Governors announced on December 16, 2015 that changes in the target federal funds rate and administered interest rates, including the primary and secondary credit rate, will be effective on the day after the Federal Open Market Committee (FOMC) policy decision.
