Rates of Interests on Advances and Discounts<sup>1</sup>

The rates on advances and discounts made by the Federal Reserve Bank of San Francisco pursuant to the provisions of the Federal Reserve Act and Regulation A are effective December 14, 2017 as set forth below:

## Rate per Annum

Advances to and discounts for Member Banks and other Depository Institutions:

(a) Primary credit advances and discounts under sections 10b, 13 and 13a of the Act and under section 201.3(a) of Regulation A

Primary Credit	2.00%
Secondary Credit	2.50%

(b) Seasonal credit advances pursuant to section 201.4(c) of

Regulation A ...... Flexible Rate<sup>2</sup>

This schedule of rates supersedes the previous schedule that was effective June 15, 2017.

<sup>2</sup> A flexible rate that takes into account rates on market sources of funds is applied to seasonal credit.
