Rates of Interests on Advances and Discounts

The rates on advances and discounts made by the Federal Reserve Bank of San Francisco pursuant to the provisions of the Federal Reserve Act and Regulation A are effective June 15, 2017 as set forth below:

	Primary Credit	1.75%
	Secondary Credit	2.00%
(b)	Seasonal credit advances pursuant to section 201.4(c) of Regulation A	Flexible Rate ¹

This schedule of rates supersedes the previous schedule that was effective March 16, 2017.

¹ A flexible rate that takes into account rates on market sources of funds is applied to seasonal credit.
