





# Population with High School Diploma/GED or Above, 2013









### Population by Race, 2013 Linn County, OR





## Access to Computers, Smartphones, and Internet, 2013 Linn County, OR







## Population Over Age 16 by Occupation, 2013 Linn County, OR













### Housing Stock by Type, 2013 Linn County, OR



## Housing Stock by Year Constructed, 2013 Linn County, OR





# Households with No Personal Vehicles Available, 2013


